**Weekly Rates**

Payment for the first week is due on or before Parent Orientation on Monday, August 11<sup>th</sup> Subsequent payments must be received on or before the first day of attendance of each week. Payments may be made any number of weeks in advance and reflect time reserved for your child, not actual attendance. **NO CREDIT** is given for holidays, sick days or no-show days.

\*Sibling discount applied to 2<sup>nd</sup> child in preschool with the lesser tuition **OR**, if second child is in elementary, sibling discount is applied to the elementary-aged child's tuition if preschooler attends 5-day program. No discount will be applied to elementary-aged child when preschooler only attends 3-day or 4-day program.

1. Enrollment is open to children who turn 18 months prior to September 30, 2014.
2. Class size is limited to 16 children per day with a 10:1 ratio, except in the toddler room where there is a 6 children per day maximum. A lead teacher is assigned to each classroom with an assistant added when enrollment in a classroom exceeds ratio.
3. Children will be placed in classrooms according to their age and attendance needs. Final room and teacher placement is at the discretion of the Preschool Director.
4. The preschool operates from 6:30 a.m. to 6:00 p.m. Actual class time runs from 8:30 a.m. to 3:15 p.m.

We do not provide a breakfast program; however, you may elect to send a “sack” breakfast with your child from home if he/she arrives before 7:45 A.M. We will provide milk for cereal or to drink at no additional cost. (Please only send items with sound nutritional value, i.e. bagel, fruit, yogurt, cereal). Morning snack served at 9:00 – Lunch at 11:30 – Afternoon Snack at 3:00.

5. Tuition for the school year program (August 18, 2014 – June 5, 2015: 42 weeks) is charged weekly and must be paid in advance of service. Payment for the first week of school is due on or before Parent Orientation on Monday, August 19<sup>th</sup>. Subsequent payments must be received on or before the first day of attendance of each week. Tuition charges reflect ***time reserved*** for your child, not actual attendance. **NO CREDIT** is given for holiday, sick or no-show days. Payment may be made any number of weeks in advance. A 10% late fee will automatically be added to any account remaining unpaid after 2 weeks unless arrangements have been made with the preschool office. Your student will **not** be allowed to attend and may be in jeopardy of losing placement in the registry if the account falls in arrears more than two weeks. If a student is dropped from the registry, re-enrollment is subject to availability and a \$100 reentry fee in addition to all past due payments. Tuition must be paid in full for students to participate in the graduation ceremony (May 20, 2015). Students may not start a new school year if there is an outstanding balance from the previous year in the Preschool Program or the Elementary School. A flexible attendance summer program will be available June 8 – August 7, 2015.
